The boundaries of the research society are the players of the football team for the halls of Al-Farahidi University, the research sample of them was chosen in an intentional manner by (100%), who numbered (7) players for the football team for Al-Farahidi University, who continue to last year (2021-2022).

### Measurement Tools and Test:

The tools of measuring each of the (Freiburg List of the Personality, and the Design of the Joe Will), depending on the theoretical framework for each of: the feature that is the characteristic or the fixed characteristic that distinguishes it from

others, it includes physical, motor, mental and social features that include intelligence, capabilities and inclinations. (Al-Razi, 1986), and the personality that is the constant and permanent organization to some extent for the individual's nature, his mood and mental and physical composition. It defines his compatibility methods with his environment in a distinctive way. (Salim, 2002), and the motivation of achievement, which is the motivation of achievement in the sports field is a multi-dimensional system that works to stir the effort associated with the sports field and achievement and determine its nature, destination, intensity and duration with the aim of the distinguished achievement of the goals. (Badran, 2003) After applying the two measures to the sample, The searcher verified to have the study data processed using the Social Statistical Package System (SPSS) version (V26) by automatically extracting the percentage values, the mean, the standard deviation, the stability coefficient (Gtman), and the T-test for one sample and the Linear Correlation Coefficient, Contribution Ratio, Standard Estimate Error, Conformity Quality Test (F), and Slope (Effect) of Linear correlation (T) Test.

The simple correlation laboratory between personal features and the achievement of achievement (0.964), and the slope of slope

(0.929)The value of (f) (65.751) was reached.

Through these statistical procedures, it is clear to us that there is a relationship between personal features and motivation for achievement among the players of the football team at Al -Farahidi University, as some personal features of the players such as (self -confidence, calm, emotional balance, control, control, depression, social) were. Some other features were low such as (nervousness, dispersion, emotion, aggression), and high achievement levels for them.

Mohamed Hassan Allawi (2004) indicated that the motivation of sports achievement is the player's readiness to meet the positions of sports competition and try to excel and privilege in light of a specific level or standard of levels or criteria of excellence by showing the largest possible amount of activity, effectiveness and perseverance as an expression of the desire for struggle and struggle from In order to excel and privilege in the positions of sports competition. (Allawi, 2004) Heba Abdel Halim Abdel -Rabah (2014) indicated that the personal feature means a group of moods that distinguish the individual from others and means the group of behavioral actions that are characterized by relative work, which are hereditary or acquired and characterized by flexibility in responding to the creation and directing of neutral forms of expressive behavior in positions Certain. (Abd Rabah, 2014) The researchers believe that the characteristic in the sports field is a relatively fixed advantage or condition that determines the behavior of the sporting individual in the various positions of the game and its distinction from others in an apparent or not apparent way, such as the way of thinking or enthusiasm and self - confidence.
